General Partners choosing to register under Article 63 “Exemption for Special Business Activities Directed at Qualified Institutional Investors” must file a Form 20 notification that among other things identifies a Japan Representative appointed by the fund manager or General Partner. Teneo Partners will take on the role of Japan Representative, coordinating with Japan counsel for the purpose of initially filing the Form 20 and assisting with the annual filing of the annual fund manager report that is required by the Financial Services Agency.
